If the emergency guardian has authority for financial decisionmaking specified above and a conservator for the alleged incapacitated individual has not been appointed, the emergency guardian must safeguard any assets held by the alleged incapacitated individual and during the period of appointment and subject to any further Order of the Court may only expend the individual's assets for the necessary support and care of the individual.

4. If emergency co-guardians are appointed, the signature of one co-guardian:

is sufficient to authorize any matter.

is not sufficient authorization.

5. This emergency guardianship shall terminate 10 days from the date of this Order, or upon further Order of the Court.
